



What to expect while taking DUVYZAT

Once you have been prescribed DUVYZAT, your healthcare team will closely monitor your health through regular testing. This guide can help you feel prepared and stay informed at every step.

Regular monitoring with DUVYZAT







There are 2 blood tests you can expect regularly after starting DUVYZAT:

- Blood cell count (complete blood count [CBC] + differential) to check the levels of different types of cells in your blood
- Triglycerides to check the level of a type of fat in your blood

These lab tests are more frequent at the beginning of treatment and may become less frequent over time.

See the chart below to help you keep track of when blood tests will need to be scheduled after you've started treatment with DUVYZAT.

*Blood tests are every 2 weeks for the first 2 months.

Some lab tests require fasting. Check with your healthcare provider before your appointments to confirm if fasting is required.

ITF ARC offers in-home lab monitoring to help support routine testing

The in-home lab monitoring program includes:

- In-home blood testing with a registered nurse
- Flexible scheduling to fit your family's routine
- Lab reports sent to your healthcare provider to help inform treatment decisions

How it works:



ITF ARC partners with Naven Health and PANTHERx to offer in-home lab monitoring to enrolled patients.

In-home lab monitoring service provider



Nurses from Naven Health will contact you directly to schedule and manage your in-home appointments. Naven Health will also communicate lab results directly to your healthcare provider.



Dedicated specialty pharmacy for DUVYZAT

In addition to coordinating care as directed by your healthcare provider, PANTHERx helps you manage your DUVYZAT prescription with offerings such as refill reminders and insurance navigation.

Once you're enrolled:

You will be contacted directly by Naven Health to prepare you for your first in-home visit.

- Your first visit will take about 2 hours. During this time, you will be introduced to your Naven Nurse and asked to complete a few forms before your care starts. Your nurse will also schedule your next appointment during this visit
- Follow-up visits will take about an hour

The DUVYZAT In-Home Lab Monitoring Program is only available in each US state and the District of Columbia. Program rules apply.

For people living in NY, NJ, or RI: State laws require Labcorp to bill your health insurance for the lab tests included in the DUVYZAT In-Home Lab Monitoring Program. You may still be responsible for costs such as co-pays, deductibles, or co-insurance, depending on your insurance plan. Patients without insurance will be billed directly by Labcorp.
